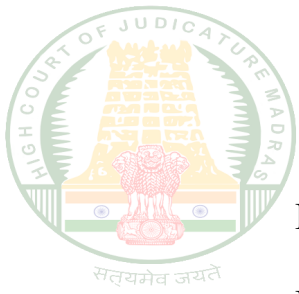

ORDER

An order dated 27.10.2023 and its summary and the consequential proceedings for submission of appeal in Form GST APL-02 dated 22.08.2024 are assailed in this writ petition on the ground of alleged breach of principles of natural justice.

2.Mr.L.Gokulraj, learned Government Counsel (Tax), accepts notice on behalf of the respondents.

3.The period of limitation for filing an appeal has expired. On instructions, learned counsel for the petitioner agrees to pay 100% of the disputed tax demand. An endorsement to that effect is made on the bundle.

4.Subject to the condition that the petitioner remits 100% of the disputed tax demand, as agreed to, within thirty days from the date of receipt of a copy of this order, the impugned orders are set aside and the matter is remanded for re-consideration by the first respondent. After providing a reasonable opportunity to the petitioner, a fresh order shall be issued within three months



from the date of remittance of 100% of the disputed tax demand.
