Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, to call for the entire records to quash 2nd respondent order dated 24th June 2024 and Direct to the 1st respondent the Chairman / CEO, L.I.C of India Mumbai -21 to obey the supreme court of India, High Court of Madras orders as per in W.p. 29284 of 2005 dated 26.11.2008 in W.A. No 1490 of 2010 dated 24.03.2010 and SLP CA No 5186-5187 of 2011 order dated 29.07.2015, and W.A. 1140 of 2017 order dated 14.06.2018, W.P. No 18228 / 2017 W.P. No 26518/2019 order dated 09.09.2019 Crl. O.P. Nos 4380/2017, 1179 5443/2020 order dated 02.12.2020 W.p. Nos 40853 of 2015, 41013 of 2015 order dated 21.07.2023 and ordered in W.M.P. Nos. 9183 / 23, 9185/23, 7685/23, 7694/23, 7682/23, 9182/23 and 9186/23 and granting the other benefits to furnish to be released 161 month salary IB, ACA other monetary benefits pension and gratuity allotment of existing agency organization (SBA Categor) as secure the L.I.C. Order

(Order of the Court was made by S.M.Subramaniam J.)

The petitioner in person would submit that he was holding the post of Development Officer in the Life Insurance Corporation of India and his monetary benefits, pension and gratuity allotment amounts due to him has not been settled. Thus he made several representations to the Authorities, for which there are no response. Thus the present Writ Petition has been filed.

2. It is needless to state that the grievance raised by an employee is to be addressed by the Life Insurance Corporation of India administration. The petitioner states that he served as Development Officer and the monetary benefits, pension and gratuity allotment due to him has not been paid.

3. Thus, the respondents are directed to consider the representation submitted by the petitioner regarding settlement of monetary benefits, pension and gratuity allotment in accordance with law and take a decision and pass appropriate orders on merits and in accordance with law as expeditiously as possible, preferably within a period of eight (8) weeks from the date of receipt of a copy of this order.



4. With these directions, this Writ Petition is **disposed of**. No costs.

Consequently, the connected miscellaneous petitions are closed.
