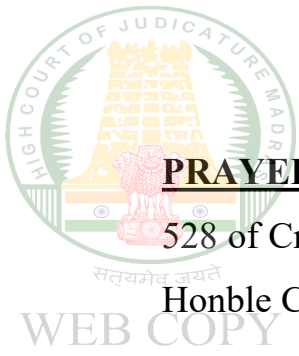

This petition has been filed to extend the time for executing the order passed by this Court in Crl.O.P.No.10005 of 2026 dated 21.04.2026.

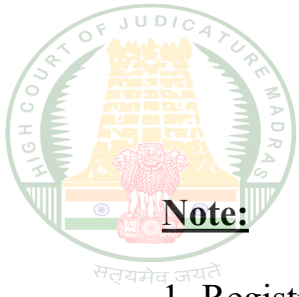
2. Heard the learned counsel for the petitioner and the learned Government Advocate appearing for the respondent.
