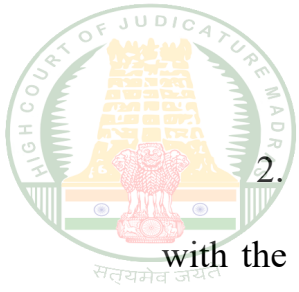
Prayer: Criminal Miscellaneous Petition filed under section 438 of Cr.P.C.,

ORDER

This Criminal Miscellaneous Petition has been filed to extend the time
granted to comply with the order dated 08.04.2026 in Crl.OP.No.7389 of 2026.



2. The learned counsel for the petitioners submitted that, in compliance with the aforesaid order, the petitioners had already obtained a Demand Draft for a sum of Rs.10,00,000/-. However, due to the delay in obtaining the Demand Draft, the petitioners could not comply with the condition within the stipulated time. He therefore sought an extension of one week time to comply with the said condition.
