This petition has been filed to condone the delay of 267 days in filing the above appeal.

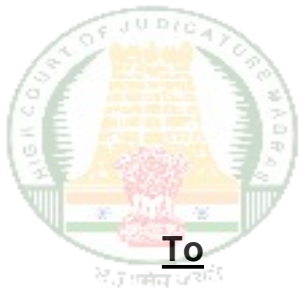
2. Heard the learned counsel for the petitioner and the learned counsels for the respondents no.1 and 3.
