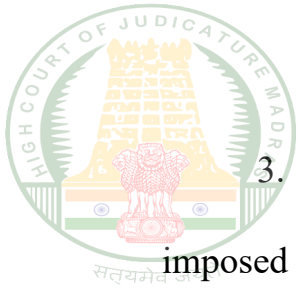

Considering the same, the stipulation in Paragraph No.7(b) imposed on the Petitioner/Appellant in Crl.A.No.471 of 2026 dated 29.04.2026 that “ the appellants shall appear before the trial Court, on all working days at 10.30a.m until further orders”, is modified to the effect that “ ***the Petitioner/Appellant shall appear before the trial Court once in 15 days (on working days) at 10.30 a.m.,*** until further orders.
