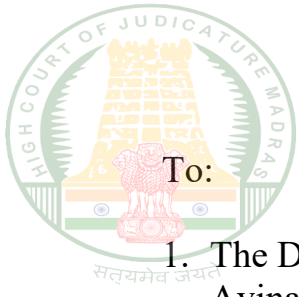
This petition is filed to extend the time limit for executing conditions of order which was passed by this Court in Crl.O.P.No.12330 of 2026 dated 13.05.2026.
