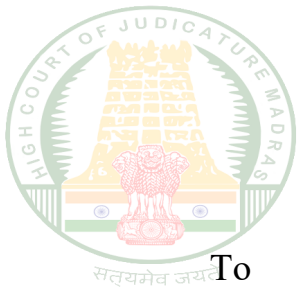
3. The learned counsel for Government of Tamil Nadu (Crl.Side),
