ORDER

This Writ Petition has been filed to direct the respondents to consider the petitioner's representation dated 10.05.2026.

2. The case of the petitioner is that the petitioner has made a



representation dated 10.05.2026 before the respondent for cancellation of UDR patta in S.No.449/1A, 1B, 1C and 1D, re-survey the lands and issue the new patta in S.No.449/1A, 1B, 1C and 1D, situate at South Avinasipalayam, Thiruppur South, Thiruppur district.
