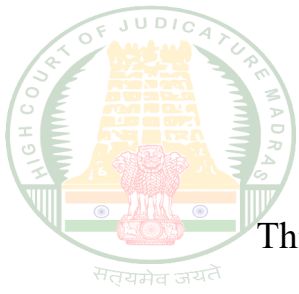

**ORDER**

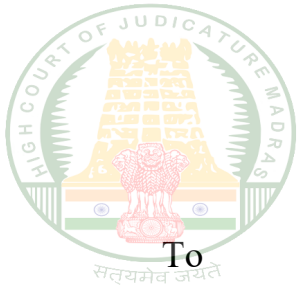
2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondent.

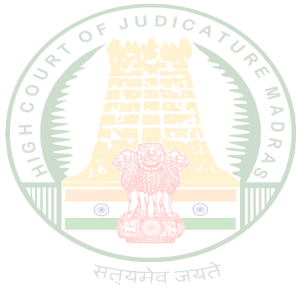
