ORDER

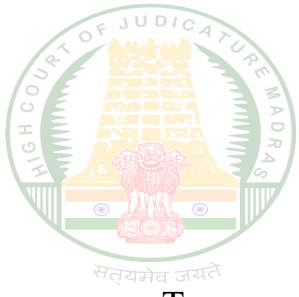
(Order of the Court was made by G.Jayachandran J.)
