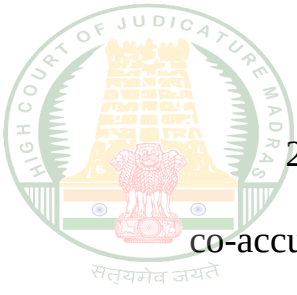
PRAYER : Criminal Original Petition filed under Section 483 of BNSS, 2023, to enlarge the petitioner on bail concerned in Crime No.458 of 2026 pending on the file of the respondent police.

ORDER

The petitioner, who was arrested and remanded to judicial custody on 25.05.2026 for the alleged offences under Sections 296(b), 126(2), 132, 109 and 351(3) of the Bharatiya Nyaya Sanhita, 2023 and Section 27(2) of the Arms Act, in Crime No.458 of 2026 on the file of the respondent police, seeks bail.

2. The allegation against the petitioner is that, while the petitioner and the co-accused were allegedly threatening members of the public by brandishing a billhook and demanding money from them, the defacto complainant, who is a Sub-Inspector of Police, questioned their conduct. It is alleged that the petitioner thereafter assaulted the defacto complainant and threatened him with dire consequences. Hence, the case.

3. The learned counsel for the petitioner would submit that the petitioner is innocent and has been falsely implicated in this case. He would further submit that the petitioner has been in custody since 25.05.2026 and is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed for the grant of bail.

4. The learned Government Advocate (Crl. Side) appearing for the respondent, while opposing the grant of bail to the petitioner, reiterated the prosecution case and, on instructions, submitted that the petitioner has no bad antecedents and that the investigation has already been completed.

5. Though this is a case involving an alleged assault on a Sub-Inspector of Police while discharging his official duties, considering the period of incarceration undergone by the petitioner, the fact that the petitioner has no bad



antecedents, and also the fact that the investigation has already been completed, this Court is inclined to enlarge the petitioner on bail, subject to certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail on their executing a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate-I, Myladuthurai and subject to the following conditions:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the learned Judicial Magistrate-I, Mayiladuthurai everyday at 10.30 a.m. until further orders;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with the evidence or witness either during investigation or trial;

[e] on breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions had been imposed and the petitioner released on bail by the learned Magistrate/Trial Court itself,

as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]***;

[f] if the petitioner thereafter abscond, a fresh FIR may be registered under Section 269 of the Bharatiya Nyaya Sanhita, 2023.
