## **ORDER**

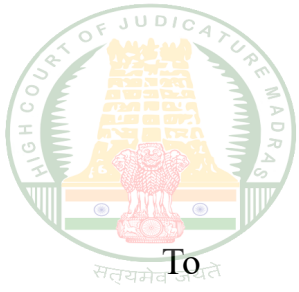


7. Accordingly, the Executing Court is directed not to proceed further with E.P.No.2 of 2009, until the appeal is finally disposed of.
