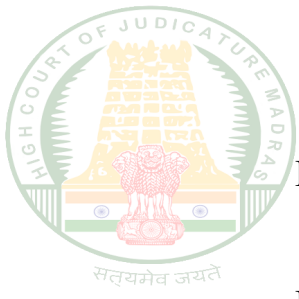

### **ORDER**

This Writ Petition has been filed to direct the respondents to consider the petitioners' representation dated 01.06.2022.
