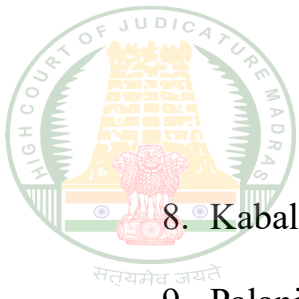

2. Being satisfied with the reasons stated in the affidavit filed in support of the petition, the delay is condoned and this petition is allowed.

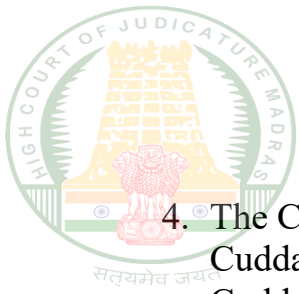
