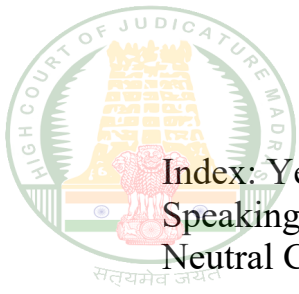
2. Heard the learned counsel for both side and perused the materials available on record.
