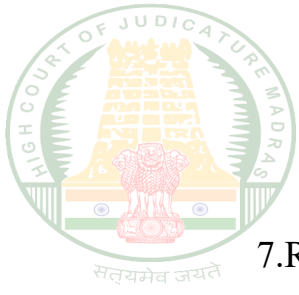
2.Mr.N.Dinesh, learned Government Advocate appeared for the 1st respondent and filed counter, which is taken on record.
