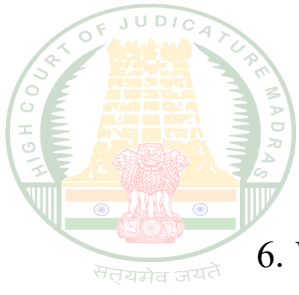
This Writ Petition has been filed seeking for disposal of petitioner's appeal dated 21.03.2025, pending on the file of the first respondent.

Considering the limited relief sought by the learned counsel for the petitioner, this Court without expressing any opinion on the merits of the case, directs the first respondent to dispose of the petitioner's appeal dated 21.03.2025 on merits and in accordance with law, within a period of eight (8) weeks from the date of receipt of a copy of this order.
