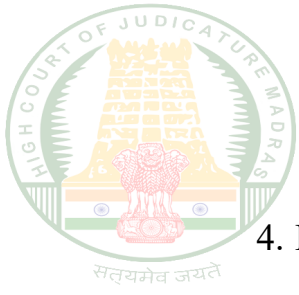
ORDER

3. In view of the dictum law laid down by the Hon'ble Supreme Court in the case of *B.S.Joshi & Ors. Vs State of Haryana & Anr.*¹, this is a fit case to exercise the extraordinary jurisdiction under Section 528 of BNSS to quash the proceedings.
