PRAYER : Criminal Original Petition filed under Section 483 of BNSS, 2023, to enlarge the petitioner on bail concerned in Crime No.118 of 2026 pending on the file of the respondent police.

ORDER

The petitioner, who was arrested and remanded to judicial custody on 15.04.2026 for the alleged offences under Section 194(1) of BNSS, 2023, subsequently altered to Section 103(1) of the Bharatiya Nyaya Sanhita, 2023, in Crime No.118 of 2026 on the file of the respondent police, seeks bail.



2. It is the case of the prosecution that, while the petitioner and the deceased were consuming liquor together, a wordy quarrel arose, during which the petitioner allegedly attacked the deceased with his hands, resulting in his death. Hence, the case.

3. The learned counsel appearing for the petitioner would submit that the petitioner is innocent and has been falsely implicated in this case. He would further submit that the petitioner has been in judicial custody since 15.04.2026 and is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed for the grant of bail.

4. The learned Government Advocate (Crl. Side) appearing for the respondent, while opposing the grant of bail, reiterated the prosecution case and, on instructions, submitted that a major portion of the investigation has already been completed and that the petitioner has no bad antecedents.

5. Considering the above facts and circumstances, particularly the nature of the allegations, the fact that the occurrence appears to have arisen out of a wordy quarrel while the petitioner and the deceased were consuming liquor together, the period of incarceration undergone by the petitioner, the fact that the petitioner has no bad antecedents, and also the fact that a major portion of the



investigation has already been completed, this Court is inclined to enlarge the petitioner on bail, subject to certain conditions.

Accordingly, the petitioner is ordered to be released on bail on their executing a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two sureties each for a like sum to the satisfaction of the learned District Munsif cum Judicial Magistrate Court, Pallavaram, and subject to the following conditions:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police everyday at 10.30 a.m. until further orders;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with the evidence or witness either during investigation or trial;

[e] on breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions had been imposed and the petitioner released on bail by the learned Magistrate/Trial Court itself, as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs.**
