4. This writ petition (Criminal) stands disposed. No costs.

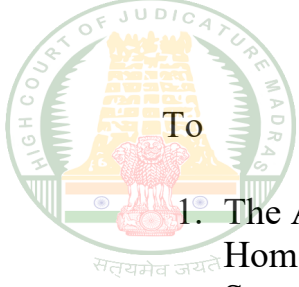
