COMMON ORDER

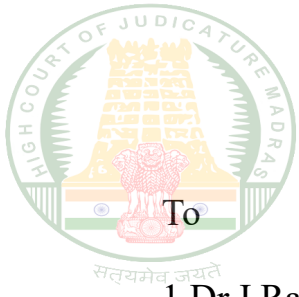
