3. It is seen that the petitioner has lodged complaint before the respondent on 09.06.2026 and the same is still pending without any progress.

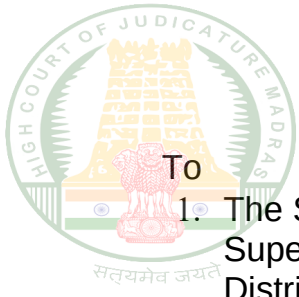
