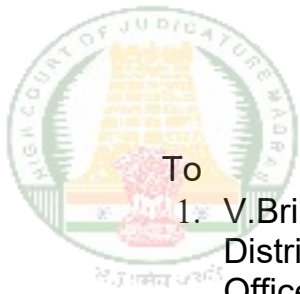
3. Correctness of the assignment as well as the conditions, if any violated, are to be examined and all further actions will be initiated.
