PRAYER : Criminal Original Petition filed under Section 483 of BNSS, 2023, to enlarge the petitioner on bail concerned in P.R.C.No.158 of 2026 in Crime No.208 of 2026 pending on the file of the respondent police.

ORDER

The petitioner, who was arrested and remanded to judicial custody on 17.03.2026 for the alleged offences under Sections 126(2), 296(b), 118(2), 351(3) BNS @ Sections 126(2), 296(b), 118(2), 103(1) and 351(3) of BNS in Crime No.208 of 2026 on the file of the respondent police, seek bail.



2. The allegation against the petitioner is that, due to previous enmity, the petitioner attacked the defacto complainant with hands and stones causing grievous injuries. Hence, the case.

3. The learned counsel appearing for the petitioner would submit that the petitioner is innocent and has been falsely implicated in this case. He would further submit that the petitioner has been in custody since 17.03.2026 and is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed for grant of bail.

4. The learned Government Advocate (Crl. Side) appearing for the respondent, while opposing the grant of bail, reiterated the prosecution case and, on instructions, fairly submitted that the investigation has already been completed and taken on file as P.R.C.No.158 of 2026 before the concerned Magistrate and that the petitioner has no bad antecedents.

5. Considering the above facts and circumstances, the period of incarceration undergone by the petitioner, the fact that the petitioner has no bad antecedents, and also the fact that the investigation has been completed and taken cognizance before the concerned Magistrate, this Court is inclined to enlarge the petitioner on bail, subject to certain conditions.



6. Accordingly, the petitioner is ordered to be released on bail on their executing a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only)

with two sureties each for a like sum to the satisfaction of the learned XIII

Metropolitan Magistrate, Egmore, and subject to the following conditions:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police everyday at 10.30 a.m. for a period of two weeks and thereafter as and when required for interrogation;

[c] the petitioner shall not abscond either during investigation or trial;

[d] the petitioner shall not tamper with the evidence or witness either during investigation or trial;

[e] on breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions had been imposed and the petitioner released on bail by the learned Magistrate/Trial Court itself, as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]***;

[f] if the petitioner thereafter abscond, a fresh FIR may be registered under Section 269 of the Bharatiya Nyaya Sanhita, 2023.
