2.As stated by Dr.T.Seenivasan on 30.01.2026, three cheques have been produced before this Court. Two cheques in the name of Mr.P.Rayin for a sum of Rs.13,38,648/- and Rs.2,35,446/- and one cheque in the name of M/s.P.Rayin Construction Company Private Limited for a sum of Rs.49,494/- have been produced before this Court.
