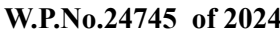

i) For issuance of a mandamus directing the Respondents to consider the Petitioners' Written representations dated 22.05.2024 to Respondents 4 5 and 6 and consequentially to grant house sites with Patta to the Petitioners in the acquired land under the Harijan Welfare Scheme measuring 3.01 Acres in Survey Nos.492/1A and 492/1B of Thelungupalayam Village Coimbatore after verifying genuinity of their claim

4. The learned Additional Government Pleader for the respondents would submit that the representation made by the petitioner would be considered and disposed of in accordance with law within the time, that may be stipulated by this Court.

5. Considering the limited scope of the prayer, sought for, in this Writ Petition, this Court without expressing any opinion with regard to the merits of the case as projected by the petitioner, either in this Writ Petition or

representation, is of the view that suffice it would be to direct the sixth respondent to dispose of the petitioners' written representations dated 22.05.2024 on merits and in accordance with law in a time bound manner, after due notice to the petitioners.

6. Accordingly, this Writ Petition is disposed of by directing the sixth respondent to consider the petitioners' representation dated 22.05.2024 and after issuing due notice to the petitioners, the same shall be disposed of by passing final orders on merits and in accordance with law as expeditiously as possible within a period of eight weeks from the date of receipt of a copy of this order. No costs.
