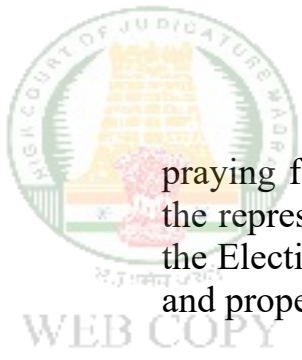

3. Accordingly, the writ petition is dismissed as infructuous. No costs. Consequently, the connected miscellaneous petition is closed.

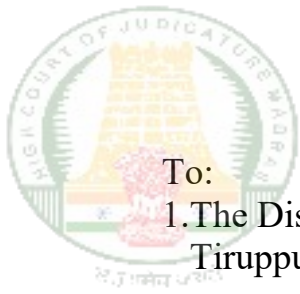
