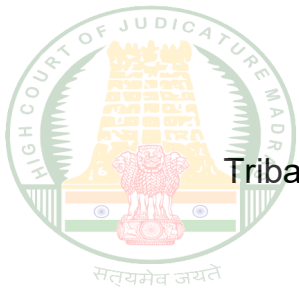

Writ Appeals have been instituted challenging the order dated 11.08.2023 in W.P.Nos. 23879, 23876 and 23880 of 2023.

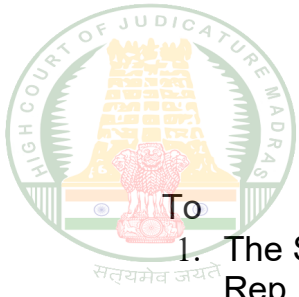
2. Learned counsel for the appellants would submit that grievance of the appellants have already been redressed.
