Prayer: Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Declaration, to declare the conditions regarding 3 years' time limit and attaining of the age of 18 years stipulated in Per.B.P.Ms.(FB) No.46, dated 13.10.1995 and in (Per.) FB TANGEDCO Proceeding No.11 (Administrative Branch) dated 11.06.2020 and the action of the respondent in rejecting the petitioner applications for compassionate appointment firstly on the ground that she did not complete 18 years of age and subsequently on the ground that her applications were not made within 3 years from the date of death of her father as illegal, irrational, arbitrary,
