Judgment

This Civil Miscellaneous Second Appeal is filed against judgment and decree dated 03.02.2025 made in CMA.No. 3 of 2024 on the file of the learned II Additional District Judge of Tiruchengode confirming the fair and decreetal order dated 22.12.2023 made in HMOP.No. 138 of 2021 on the file of Honble Sub Court, Tiruchengode
