ORDER

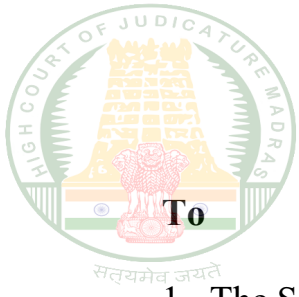
This Writ Petition has been filed challenging the order of the 3rd respondent dated 04.09.2024, cancelling the cheque signing power of the petitioner.
