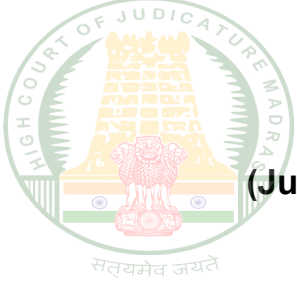

2. Recording the submission, the writ appeal stands dismissed as withdrawn. No costs. Consequently, the connected miscellaneous petitions, if any, are closed.

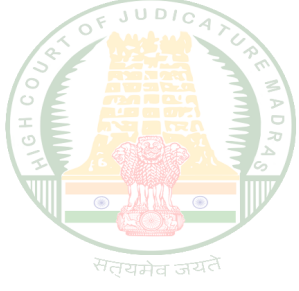
