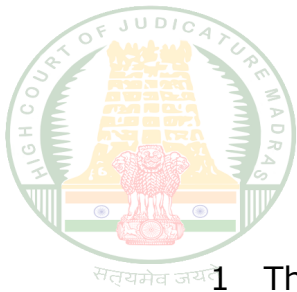

Petition filed under Article 226 of the Constitution of India to

Prayer in W.P.No.13422 of 2017:

Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorari calling for the records on the files of the first respondent in its proceedings in ORDER dated 14.05.2017, purported to communicate the direction of the second respondent in its letter dated 12.05.2017 (which has not been communicated to the petitioner) to fix temporary fee without any meeting of the Fee Committee, and quash the same as arbitrary, unreasonable, irrational, violative of natural justice and the decision of the Hon'ble Supreme Court in *P.A.Inamdar vs. State of Maharashtra (2005) 6 SCC 537*.

Petition filed under Article 226 of the Constitution of India to

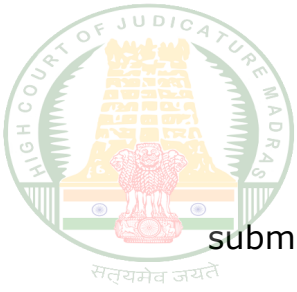
