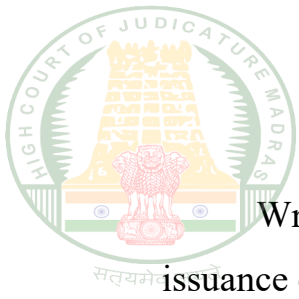

(Order of the Court was made by The Chief Justice)

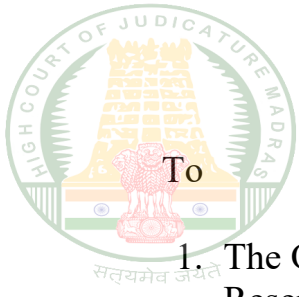
Learned counsel appearing for the petitioner seeks permission of the court to withdraw the writ petition with liberty to avail the appropriate remedy.
