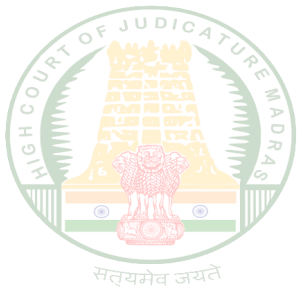

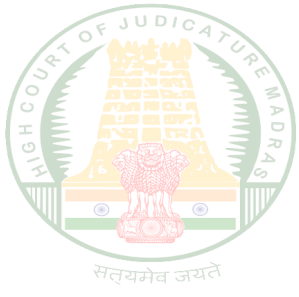
ORDER
