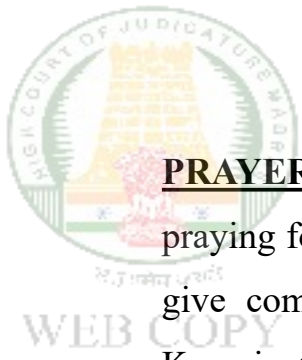

ORDER
