ORDER

When this matter was taken up for hearing, the learned Government Advocate appearing for the respondent would submit that in this case, the petitioner's representation was duly considered and joint patta was also issued as requested by him. Hence, he would submit that the prayer in this petition has become infructuous and requests this Court for dismissal of this petition.
