This petition has been filed to quash the proceedings in C.C.No.100 of 2019, on the file of the learned Judicial Magistrate, Sulur, thereby taken cognizance for the offence punishable under Section 138 of the Negotiable Instruments Act, as against this petitioner.

2. When this Court was about to dismiss the quash petition, since no ground is made out to quash the entire proceeding, the learned counsel appearing for the petitioner seeks permission of this Court to withdraw the quash petition and also sought for dispense with for the appearance of the petitioner before the trial Court.
