(Order of the Court was made by G.Arul Murugan J.)

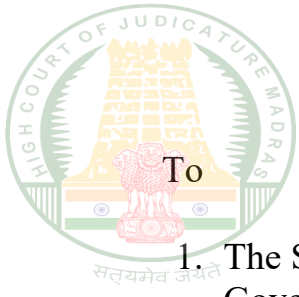
