5.This Court is not expressing any opinion on the merits of the petitioner's representation.

Accordingly, this writ petition is disposed of by directing the third respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 28.07.2025 seeking for issuance of patta in his name for the property, morefully described in the affidavit filed in support of this writ petition, after hearing the objections from the neighbouring land owners, if any or any other third party whom the third respondent deems it fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
