WMP(MD) No. 19264 of 2022

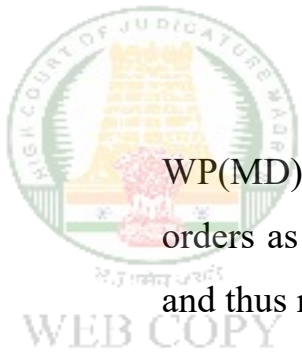
