ORDER

The petitioner seeks transfer of MCOP No.120 of 2021 from the file of Motor Accident Claims Tribunal, Vellore to Sub Court, Tiruttani.

2. Learned counsel for the petitioner submits that all the claimants are residing at Thiruvallur, which comes under the jurisdiction of Sub Court, Tiruttani and only the counsel is residing at Vellore and the petitioner finds it difficult to travel 60 kms to attend the proceedings and therefore, the petitioner seeks for transfer.

3. I have perused the materials available on record.

4. From the records, it reveals that the claimants are residing at Thiruvallur which comes under the jurisdiction of Sub Court, Tiruttani. Therefore, I am inclined to transfer MCOP No.120 of 2021 from the file of Motor Accident Claims Tribunal, Vellore to Sub Court, Tiruttani.
