ORDER

This writ petition has been filed to direct the respondent to consider the petitioner's representation dated 26.09.2023.

2. The learned counsel for the petitioner would submit that in this case, a representation was filed by the petitioner requesting the respondents to pass appropriate orders of allotment in respect of plot no.404, K.V.
