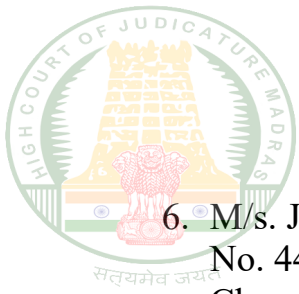

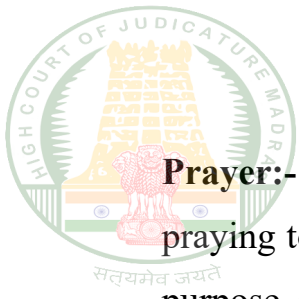

ORDER

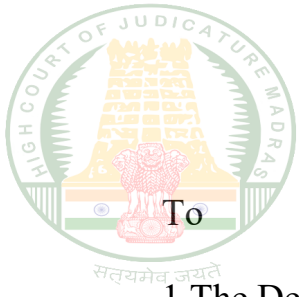
The learned counsel appearing for the petitioner submitted that the prayer sought for in this petition has become infructuous.
