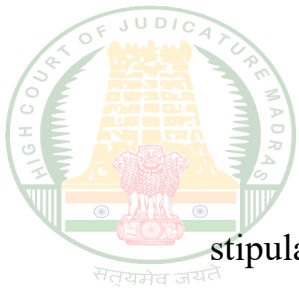

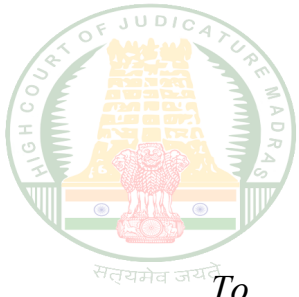
3. In the light of the above, nothing survives for adjudication. Accordingly, the Writ Petition stands disposed of. No costs.
