4. The learned Special Government Pleader appearing for the respondents would submit that the 1st respondent will consider the representation of the petitioner and pass appropriate orders on the same within a specified time.



5. In view of the above, there will be a direction to the 1st respondent to consider the petitioner's representation dated 14.06.2025 and pass appropriate orders on the same in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

6. This Writ Petition is disposed of with the above terms. No costs.
