The learned counsel for the petitioner seeks permission of this Court to withdraw the above Civil Revision Petitions and he has also made endorsements in the petitions to that effect.

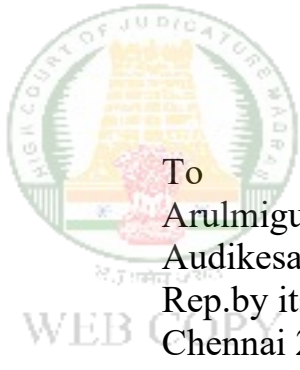
2.Recording the submission and the endorsements made by the learned counsel for the petitioner, the Civil Revision Petitions are **dismissed as withdrawn**. No costs.
