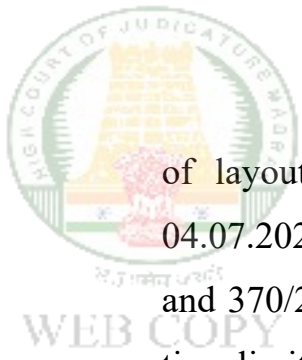

PRAYER

Writ Petition filed under Article 226 of the Constitution of India, praying to issue Writ of Mandamus, directing the 1st and 2nd respondents to consider the petitioners representation dated 14.08.2024 and thereby cancel the approval



of layout issued by the 2nd respondent Vide DTCP No. 216/2022 dated 04.07.2022 for the property comprised in Survey No. 840/1A1C1, 370/1B2A and 370/2B2 situated at Elavamalai Village, Erode Taluk and District, within a time limit to be stipulated by this Honorable Court.

ORDER

This writ petition has been filed to direct the respondents 1 & 2 to consider the petitioner's representation dated 14.08.2024.

2. The learned counsel for the petitioner would submit that in this case, the petitioner has given a representation dated 14.08.2024 to cancel the approval of layout issued by the 2nd respondent Vide DTCP No. 216/2022 dated 04.07.2022 for the property comprised in Survey No. 840/1A1C1, 370/1B2A and 370/2B2 situated at Elavamalai Village, Erode Taluk and District. However, the said representation was not at all considered by the respondent till date. Hence, this petition.

3. In reply, the learned Special Government Pleader appearing for the respondent would submit that the petitioner's representation dated 14.08.2024



will be disposed of by the 2nd respondent within a period of 12 weeks.
