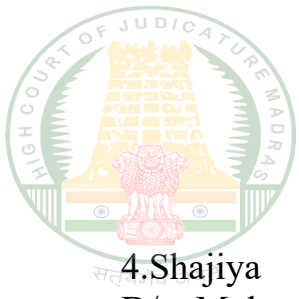

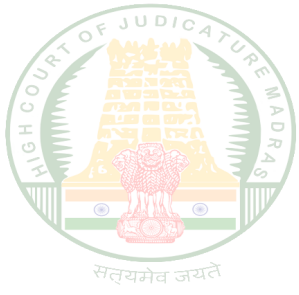

2. Heard both sides and there is no serious objection in ordering this petition.

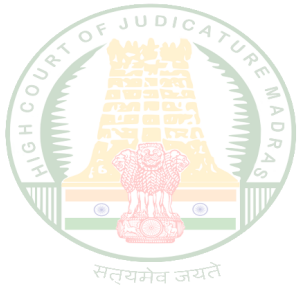
